THE E.NOPI INVITATIONAL MATH COMPETITION 2009

Daekyo Philippines Noonnoppi Inc. hereafter will be referred to as "The Company".

The person whose name and signature appears in front of this document hereafter will be referred to as "Participant".

In the case where the Participant is a minor, the signature of the parent or guardian in the front page declares that the parent or guardian acknowledges and agrees to the terms and conditions set hereafter.

1. This competition is hosted by the Company (E.nopi Head Office).
2. *Application Period:* Application of interested Participants starts from August 1, 2009 to August 30, 2009.
3. *Actual Competition Date:* October 18, 2009 (Sunday)
4. The contest is open to elementary level (Grade 1 to 6) private school students (in Metro Manila and in nearby provinces), provided that the school received an invitation and an event packet prior to the competition date.
5. *Limited Number of Slots.* There are limited slots available per grade level. Participants will be taken on a "first come, first served" basis.
6. *Qualifications:*
  - a. Interested Participant must be currently enrolled in the academic year he/she is competing.
  - b. Entry Forms must be completely filled out.
  - c. Participant must not be, at one time or another, enrolled in E.nopi Math Program.
  - d. The participant's name should be included in the Summary List of Participants to be submitted by the school coordinator to the Head Office.
  - e. The Participant (represented by the parent or guardian) must register, read, and acknowledge the full competition terms and conditions by signing on the space provided in front. The Participants who do not comply are disqualified from joining.
7. Entry forms may be acquired through your respective school coordinators.
8. *Submission of Entry Form.* Interested Participants may submit the application forms through the school coordinators. The school coordinators must submit in-person the completely filled out Entry Forms to the Company.
9. *Registration Fee.* Upon submission of the Entry Form, the interested participant shall pay a registration fee of Php250.00.
10. *Exam Booklets and Test Questions.* All test questions and test booklets will be provided by Daekyo Ltd., Korea.
11. *Exam Coverage.* Please refer to the Guidelines and Mechanics.
12. *Checking of Exam Booklets.* All booklets will be packed and sealed after the exam and will be sent back to Korea for checking.
13. *Competition Updates.* All modifications regarding the competition will be course through the School Coordinators and posted in the E.nopi websites: <http://ph.enopi.com> and <http://enopiphilippines.multiply.com>.

14. *Prizes.* The winners will receive a medal plus cash prize. The school will receive a Plaque of Recognition.
15. *Winner's Threshold.* Gold Recipient: Score  $\geq 91\%$ ; Silver Recipient  $91\% > \text{Score} \geq 81\%$ ; Bronze Recipient:  $81\% > \text{Score} \geq 71\%$ . There will only be ONE recipient per award.
16. *Awarding.* Winners will be announced through the E.nopi websites immediately after the exam results arrive from Korea. An invitation to the Awarding Ceremonies (date to be announced) will be sent through courier to the respective schools (to be distributed to the winner/s).
17. *Disclosure of Information.* The Participant agrees to disclosure by The Company and/or any party on its behalf, as it deems fit, of any or all information about the Participant as written in the Entry Form.
